There are several ways to communicate with your elected officials:

<p>By Visit</p> 	<p>Legislators are eager to meet their constituents and will try to accommodate your request for a personal meeting. Please make an appointment in advance, and understand if the legislator is called away for an unscheduled committee meeting or session. You may meet with a staff member who will be welcoming and attentive to your concerns. Legislators also meet with their constituents at coffee hours or towns hall meetings in their districts. <i>**During the COVID-19 pandemic face to face meetings may be limited. Virtual meetings may take the place of in-person meetings.</i></p>										
<p>By Phone</p> 	<p>A phone call is a quick and easy way to contact your legislator. Direct phone numbers are provided in the pages that follow.
